TERMS AND CONDITIONS

Should your application for the use of the pitch be granted, the following terms and conditions shall be deemed to apply:-

1. Your Club/Organisation will be notified of your application and if the pitch you requested is not available you will be informed if there is an available alternative.
2. All bookings must be made in accordance with these Booking Terms and Conditions.
3. Clubs/Organisations may book more than one date, any period in advance, for fixtures on a first come first served basis following the allocation of serial lets.
4. All kick off times must be strictly adhered to.
5. The Club/Organisation and the organiser's name, which appear on the application form, shall be deemed to be the hirer and shall be responsible for compliance with all Terms and Conditions.
6. Clubs/Organisations wishing to cancel a confirmed hire of a pitch must do so with the grounds man at least 48 hours before the time and date of the hire. Failure to do so may result in the full charge being made.
7. SPRA do not permit the pitch and facilities to be used except by members of the applicant's Club/Organisation or members of a visiting Club/Organisation, nor to use the facilities for any purpose other than that set out in the application.
8. SPRA cannot accept responsibility for any loss, damage or injury whatsoever arising to persons or property.
9. Clubs/Organisations will be held responsible for any damage caused as a result of misuse or vandalism by their members or visiting Club/Organisation members during the period of hire of the pitch and facility. This includes damage to the playing surface caused by unauthorised use.
10. In the case of a pitch being unfit on the day of play, the grounds man will advise the main contact and arrange an alternative date at least 48 hours prior to time and date of hire.
11. All cheques must be made payable to **Strathclyde Police Recreation Association** and forwarded to the SPRA Office at 6 Baird Street, Glasgow G4 0EZ.
